As parent or legal guardian, I hereby waive any and all rights of action that I have or may have, and/or that my child or ward has or may have, against the Releasees, jointly and severally, in consideration for the Library allowing my child or ward to participate as a volunteer. I understand that the Library has the right to discontinue the volunteer working association of my child or ward with the Library at any time and for any reason whatsoever. This Release may not be changed orally and applies in all jurisdictions. This Release is binding on my heirs, executors, legal and other representatives, administrators, successors, and assigns.

I have read this entire Consent and Release, I fully understand it, I have signed it without duress or coercion, and I agree to be bound by it. I certify that I am at least 18 years old.
